The award includes a \$2000 grant for a ministry to be chosen by the fellow. This award is named in honor of Dr. John Marshall, former pastor of Second Baptist Church in Springfield.

Nelson Fellow: Honors a faithful, mature lay individual or couple that exhibit whole-life stewardship through Christian service. The award includes a \$2000 grant for a ministry to be chosen by the fellow. This award is named after Dr. and Mrs. Thomas Nelson for their service to the local church, Missouri Baptist Convention and SBC.

Next Generation Fellow: Honors a next generation young adult child, youth or young adult in the age range of 10-25. Nominees identify missional needs and actively respond to meet those needs through the gifts of their talents, time and/or treasures. The award includes a \$1000 grant for a ministry to be chosen by the fellow.
